SECTION II - INTRODUCTION - PLEASE READ THE FOLLOWING

5. Before you take the oath of enlistment, it is important to understand the **core values** of the military organization you are about to join. You will be joining an institution of people with unique and enduring values. Inherent in all of these values is telling the truth.

6. Along with your interviewer, ensure all the information in your paperwork is correct before you enlist. Ensure they omitted nothing that might cause you to be considered for a fraudulent enlistment. Your Service is especially concerned with events that may have happened during the Delayed Entry Program (DEP) period. However, be truthful and feel free to discuss any subject about which you think your Service needs to know.

7. We will NOT give information you disclose now to the *Police, School Officials, or your Parents/Guardian*. However, all information you disclose now must be given to your Recruiting Service or the MEPS physician for review and response. Note: If you are a minor age 17 or less, your parents/guardian can legally request this information.

8. Any new or changed information must come out *now - - not after you enlist*. If your Service discovers disqualifying information after your enlistment, a court-martial for fraudulent enlistment may result.
