The United States Military Entrance

Processing Command is the vital link between recruiting and training America's armed forces. The joint-service command evaluates applicants by applying established Department of Defense standards during military processing, thereby providing continual military enlistments, thus strengthening national security.

The command's national headquarters and its Eastern and Western Sector headquarters are located in North Chicago, Illinois. Twelve battalions provide direct support to and oversight of 65 Military Entrance Processing Stations and one Remote Processing Station. These 66 efficiently designed stations are located on military installations, and in both federal and commercially leased buildings, throughout the contiguous United States and in Honolulu, Hawaii; Anchorage, Alaska; and San Juan, Puerto Rico.

The command is staffed by approximately 20 percent uniformed personnel and 80 percent Department of the Army civilians who weave USMEPCOM's values of Integrity, Teamwork, Professionalism and Respect into every aspect of military processing. The command's more than 3,000 personnel provide "Red Carpet" treatment to applicants and are committed to sustaining the quality of the All-Volunteer Force through state-of-the-art enlistment screening.

Applicant screening includes three main portions – a testing evaluation, medical evaluation, and background investigation.

There are two versions of the Armed Services Vocational Aptitude Battery, or ASVAB – student and enlistment. The ASVAB Career Exploration Program offers the student version, a validated aptitude test and interest assessment. The CEP offers career planning tools and assists high school students in using ASVAB results for career exploration. Student ASVAB results also provide a "talent pool" of qualified potential enlistees to the military recruiting services. More than 616,000 high school students took the student ASVAB during fiscal year 2022. During that same year,

274,000 applicants took the enlistment ASVAB, also used to match military applicants with career fields. In the next step of processing,

medical personnel perform thorough examinations that evaluate an applicant's medical history and current physical condition in an effort to determine if they can meet the challenges of initial entry training and military service. In fiscal year 2022,

medical personnel administered more than 215,000 medical examinations.

Background screening of applicants is equally important to military entrance processing. It includes pre-enlistment interviews, fingerprinting, and initiating Entrance National Agency Checks.

By determining applicants' qualifications for enlistment, USMEPCOM provides the nation's nine initial entry training centers with fully qualified recruits. During fiscal year 2022, 178,245 young people met those rigid standards and raised their right hand to take the Oath of Enlistment.

The command remains focused on improving its technological capabilities and work methods. After introducing a new processing system in 2021, USMEPCOM deployed MHS GENESIS in 2022. With this, the command took on the role of creating the enlisted service member's initial health record that evolves into their lifetime health record. In 2023, USMEPCOM will continue to improve its new processing system's integration with MHS GENESIS, as part of its overall advancement toward more efficient, paperless processing.

The command's motto is "Freedom's Front Door," and, although all are welcome to approach, only those who meet Department of Defense standards will make it through. There is no other door, and passing through Freedom's Front Door is not always easy. USMEPCOM exists to ensure only qualified men and women become United States Soldiers, Marines, Sailors, Airmen, Coast Guardsmen and Space Force Guardians.
